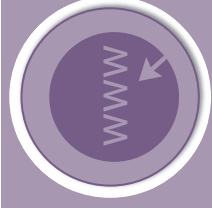
We believe everyone deserves peace of mind.™ Our mission is to provide education, outreach, and legal services for patients undergoing cancer treatment.

Go online to www.clauses4causes.gives and apply.



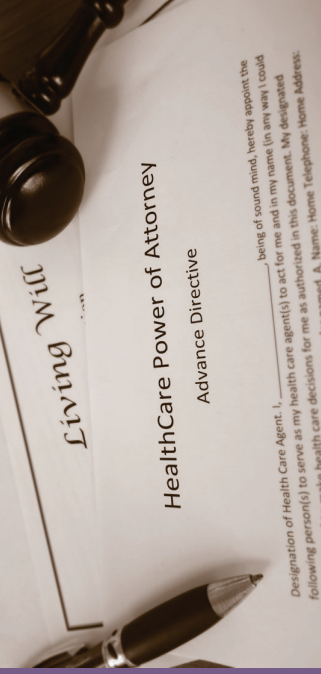
STEP 02
